Incident: Final Sentencing- Callaway County resident – Michael Kreps
Sentenced

Around mid-August 2014 an investigator with the Boone County Sheriff's
Department Cyber Crimes Task Force began an investigation after a Boone County
citizen learned a Callaway County man, Michael Kreps had sex with the citizen's
female child. In September 2014, the Task Force, along with the Callaway County
Sheriff's Department and Holts Summit Police Department served a search warrant
on Kreps residence in Holts Summit related to the investigation. During the search
warrant several computers and other media were seized.

A forensic examination was conducted months later. The examiner found
numerous images depicting sex crimes involving at least two other female children
under the age of 12. Additional information revealed that Kreps had committed
crimes against a child in Callaway, Cole and Boone County. Investigators was able
to show Kreps' girlfriend, Tenessa Wolfe was also involved with the sex crimes
against a child in Cole and Boone County. Arrest warrants were issued in
Callaway County for Kreps and Wolfe in May 2015.

Final sentencing for Michael Kreps ended today in Boone County Court

Michael Kreps pled guilty - sentenced in **Callaway County** on **September 26, 2016**
to Statutory Rape 1st, less than 14 yrs old- **sentenced to 20 years**

Michael Kreps pled guilty- sentenced in **Cole County** on **September 29, 2016** to
(7 counts) Statutory Sodomy 1st degree- less than 14 yrs old- **sentenced to Life in
prison on all counts-** to run concurrent

Michael Kreps pled guilty - sentenced in **Boone County** on **March 24, 2017** to,
Statutory Sodomy 1st degree, less than 14 yrs old (3 counts), Sexual Exploitation of
a Minor (3 counts) sentenced to **30 years in prison** on all counts- to run concurrent

Tenessa Wolfe pled guilty in **Cole County-** **June 8, 2016** to (5) counts Statutory
Sodomy 1st degree w/ person less than 14, sentenced to 25 years in prison on all
counts- to run concurrent

Tenessa Wolfe – Boone County case – still pending
