**Details:**

On Thursday, August 27, 2020, a Boonville man was arrested for 2 counts of Possession of Child Pornography, 20 images or more or 1 video, class B felony.

The investigation leading to the arrest began when a Boone County Sheriff's Department Cyber Crimes Task Force investigator received a CyberTip report from an online storage cloud service reporting child pornography being located on the account belonging to defendant.

The Task Force investigators served a search warrant on the defendant's address located in Boonville with the assistance of the Boonville Police Department. The defendant wasn't home at the time of the warrant, so Investigators located the defendant at his place of employment. Furthermore, Investigators received a statement from the defendant that indicated he was responsible for the online storage account.

The suspect is identified as 24-year-old, Addison Jones who resides at 610 7<sup>th</sup> Street in Boonville, Missouri. The defendant is currently in custody of the Cooper County Sheriff's Department being held on 100,000 cash or surety.

All suspects are considered innocent until proven guilty in a court of law.

The Boone County Sheriff's Department Cyber Crimes Task Force is comprised of investigators from the Boone County Sheriff's Department, the University of Missouri Police Department, the Federal Bureau of Investigations, and the Boone County Prosecuting Attorney's office.
