STATE'S MOTION FOR DISPOSITION OF UNCLAIMED PROPERTY

PURSUANT TO 542.301, RSMo.

Comes now the State of Missouri, by and through Craig A. Johnston, Assistant Prosecuting Attorney of Boone County, Missouri, and in support of its amended motion for disposition of unclaimed property pursuant to Section 542.301, RSMo., states to the Court as follows:

1. Section 542.301, RSMo., provides for the disposition of property seized by law enforcement that remains unclaimed a year after seizure and is no longer required for court proceedings.
2. Craig A. Johnston is an Assistant Prosecuting Attorney of Boone County, Missouri.
3. This Court has jurisdiction over this matter as the property listed in Exhibit 1, Exhibit 2, Exhibit 3, and Exhibit 4 was seized in Boone County, Missouri.
4. The Boone County Prosecuting Attorney's Office has received a request from Robert D. Carey, the Boone County Sheriff, that certain unclaimed property, more fully set forth in Exhibits 1, 2, 3, and 4, attached to this motion, be ordered forfeited by this Court so that items in Exhibit 3 may be destroyed and

items in Exhibits 1, 2, and 4 may destroyed or sold at a public sale at the discretion of the Boone County Sheriff.

5. Based upon information received from the Boone County Sheriff:

a. The property listed in Exhibits 1, 2, 3, and 4 was seized and came into the custody of the Boone County Sheriffs Office more than one year preceding the filing of this motion and came into the custody of the Sheriff by virtue of criminal investigations and performance of his official duties of office as prescribed by Missouri statutes;

b. The names and last known addresses of all persons who may have had an interest in the property are listed in Exhibits 1, 2, 3, and 4;

c. The true owners of the property are listed in Exhibits 1, 3, and 4, and have received notice by mail to their last known address or their addresses are unknown to the Boone County Sheriff, and to his knowledge no claims have been filed within one year of the seizure of the property.

6. The property listed in Exhibits 1, 2, 3, and 4 is no longer needed as evidence, and the Boone County Sheriff requests an order of this Court permitting destruction of this evidence.

7. The property listed in Exhibits 1, 2, 3, and 4 is no longer needed as evidence, and the Boone County Sheriff requests an order of this Court permitting the disposition of this evidence at a public sheriffs sale or to be destroyed at the discretion of the Boone County Sheriff.

WHEREFORE, the State of Missouri prays this Court enter an order directing that the property listed in Exhibit 3 be destroyed and for an order directing that the property listed in Exhibits 1, 2, and 4 be sold at public sale or destroyed at the discretion of the Boone County Sheriff, with the proceeds of said sale, less any expenses of preservation and sale, to be paid into the County treasury for the use of the County, and for any further orders this Courts finds appropriate.
